To submit an application, students should complete the following steps.

- 1. The three documents required for application to be considered to receive a scholarship to attend the 2021 Penn Law Pre-College Academy are:
 - a. Application Form
 - b. Teacher/Counselor Recommendation Form
 - c. High School Transcript
- 2. Return the completed Application Form along with any additional pages used to answer the essay questions to lep@law.upenn.edu.
- 3. The teacher or counselor recommending the student should send their Recommendation Form directly to lep@law.upenn.edu.
- 4. The student or counselor should send the high school transcript to lep@law.upenn.edu.
- 5. Once all application materials have been received, you will receive a confirmation e-mail regarding the successful receipt of your scholarship application.

^{*} The full program scholarships cover all program fees, housing, meals while on campus, access to Penn's fitness centers and other recreational facilities, and all activities and trips associated with the program. The scholarship **does not** cover expenses associated with travel to and from the Penn Law campus in Philadelphia.
