



#### STATEMENT ON THE RISE OF ANTI-ASIAN VIOLENCE IN 2021

Penn APALSA and SALSA <u>once again condemn</u> the horrific surge in anti-Asian violence over the past several weeks and calls our greater community to action. Since the start of the pandemic, Asian people have been widely discriminated against as the source of the virus, and over 2,800 hate crimes against members of our communities have been reported.<sup>1</sup> During the first few weeks of 2021, this disturbing trend has not only persisted but worsened.<sup>2</sup> Alarmingly, many of these recent assaults have targeted some of the most vulnerable members of our communities: our elders.<sup>3</sup> Senior citizens of all races already bear a disproportionate risk during the pandemic. Now, our Asian elders — our grandparents, parents, aunts, and uncles—live in fear of a second pandemic: horrific, racist violence.

Anti-Asian racism is not new. Through the 19th and 20th centuries, Asian Americans were caricatured as disloyal: a "Yellow Peril" which informed racist laws and policies like the Chinese Exclusion Act and, Japanese internment. Similar anti-South and anti-Southeast Asian sentiment manifested itself through atrocities like the Bellingham and Watson Race Riots and the more recent *Dotbusters* hate group. Tragically, these stories are untold and overlooked in American history, erasing our past and contributions to this country.

Today, we are simultaneously ignored and stereotyped as the "model minority." This false designation erases our historical and contemporary struggle, insidiously divides racial minorities, and perpetuates anti-Blackness.<sup>5</sup> At the same time, the American

zeitgeist steadfastly refuses to perceive Asian Americans as participants in the American story, continuously othering through erasure<sup>6</sup> and stereotyping,<sup>7</sup> or in more serious cases, false accusations of espionage<sup>8</sup> and terrorism.<sup>9</sup> While these depictions most frequently manifest themselves in cultural depictions (or lack thereof), they also are the root cause of decades of xenophobic and racist violence.

In light of the surge in anti-Asian racism, we call upon our allies to stand in solidarity with the Asian American community and condemn these attacks. In this spirit, APALSA is launching a matching fundraiser to support AAPI social justice organizations listed below. Organizations at both the local and national level are supporting AAPI communities across the nation to combat this newest surge of anti-Asian racism, which compounds the already deeply-felt difficulties of COVID-19. If you are able, please consider donating to these organizations to help ensure that their incredible support and services continue to reach AAPI communities during this critical time. APALSA commits to matching up to \$2,000 to maximize the impact of each dollar donated to these important causes. Finally, we condemn *all* racism laid bare by COVID-19 and the enduring legacy of racist policing. We stand with other communities of color, and we refuse to scapegoat and demonize each other. We stand especially with our Black siblings in resistance to the racism that has pitted our communities against each other. We honor their leadership in fighting for equality and the eradication of white supremacy in our society and echo their calls for solidarity, justice and peace.

Our struggle to combat anti-Asian violence is inseparable from this broader movement seeking equality, and we are stronger when we all stand united. We ask for your support in amplifying the voices of our elders and drawing attention to this horrific pattern of violence largely underreported in the media, and we ask for your active allyship as we launch fundraising efforts to directly support our communities.
