

APPENDIX G. SURVEY PRESENTATION

1. Instructions and Survey Layout

Subjects participating in the study via Amazon's Mechanical Turk system were able to locate it through a keyword search or via Mechanical Turk's online listing of available tasks. Upon finding the study, subjects were presented with an informational screen giving a brief overview of the study, and could choose to view the instructions without committing to taking it. The initial screen appeared as follows:



Upon clicking "View a HIT in this group," participants were given the survey instructions and could choose to participate by clicking "Accept HIT." Upon doing so, they were again presented with the instructions, and were told to read them carefully. Participants then began the study by clicking a "Launch" button in the lower half of the page.

All study participants, paid or volunteer, were presented with identical survey instructs. After the initial selection of the HIT, the survey taken by participants from Mechanical Turk was identical to that taken by volunteers.

The first screen of the survey contained instructions, and appeared as follows:

Participants were next presented with an introduction to the "milestone offenses" used throughout the survey. Text instructions were followed by a sample milestone chart, accompanied by a sample "test offense." The arrangement was exactly as would be found later in

the survey. Each participant was asked to answer "Level 4" for this question; any survey that did not show a Level 4 answer to this question was closely scrutinized and could be subject to removal from the study if further factors indicating invalid data were found. The milestone offenses sample page appeared as follows:


Interspersed with the first 55 test questions were demographic questions designed to provide information on our subject pool. Each demographic question was presented as follows:

















After the subject had completed the first 55 test questions, he or she was presented with a screen thanking them for completing the required portion of the survey. This screen was designed to increase participation in the questions that followed, but granted a password to input into Mechanical Turk. These passwords were intended to force the user to press "Submit HIT" in Mechanical Turk after they had finished the survey; we could not pay them if they did not (this is a technical limitation inherent to the Mechanical Turk system). Providing passwords also enabled us to quickly view where the user had stopped taking the survey, without consulting the actual data, and finally provided the user with definite endpoints while providing encouragement to complete as many questions as possible. The midpoint notice appeared as follows:

Thank you for completing the required portion of our survey. Your responses will be invaluable in helping to improve the criminal law in Pennsylvania and in other states. So far, you have earned 65 cents.


