Paul is the retired Chairman of the Board of Capital Research and Management Company. Prior to joining Capital in 1985, Paul was a Partner in the law firm of Dechert Price & Rhoads in Washington, D.C. From 1974 to 1977, he was a Senior Attorney for the U.S. Securities and Exchange Commission.

He recently served as acting President and CEO of National Public Radio from September 2013-July 2014. He also serves as Chairman of the Board of the Los Angeles County Museum of Natural History, and Trustee of the Huntington Library, Museum and Gardens in San Marino.

In addition, Paul is a Trustee for Princeton University, a member of the Board of Overseers of the University of Pennsylvania Law School (Chairman 2007-2013), a Trustee of Georgetown Preparatory School, a member of the National Council of the American Enterprise Institute, a member of the Board of Overseers of Hoover Institution at Stanford University, and a member of the Policy Circle at Pardee-Rand Graduate School.

Paul earned a bachelor's degree in economics from Princeton University, an M.B.A. from the Wharton School, and a J.D. from University of Pennsylvania Law School.



Heather, an artist residing in California, has more than 25 years of experience in nonprofit board leadership. Beginning with the Crescenta-Cañada Family YMCA in 1986, she has since served on ten boards and committees for both local and global nonprofit organizations. Locally, she is a Trustee and the former Board Chair of Descanso Gardens, a 160-acre green space in La Cañada.

She is a trustee of Princeton Theological Seminary, where she also serves as co-chair of the Bicentennial Capital Campaign and she is a member of the Advisory Council for Princeton University Art Museum as well as a Trustee for her alma mater, Vassar College. As Chair of the Salzburg Global Seminar, she has helped to envision a

new strategic direction for the next decade. Finally, she is a member of the Board of Directors for African Wildlife Foundation.

As an artist, her focus is on plein air painting – primarily landscapes and still lifes. She has had successful shows in Los Angeles and on the East Coast. Her paintings are in collections throughout the country. Prior to becoming an artist, she worked in advertising at J. Walter Thompson in New York, for the U.S. Postal Service in Washington D.C., and at Chesapeake and Potomac (AT&T) where she created the prototype residential marketing plan later used by Phone Center Stores across the country. While in Washington, she and Paul were members of a 13-person group that believed in, raised the money for, and built the Vietnam Veterans Memorial. Following the birth of her two children she founded Marketing Management Inc., a marketing consulting firm.

As Secretary of the U.S. Department of Homeland Security from 2005 to 2009, Michael Chertoff led the country in blocking would-be terrorists from crossing our borders or implementing their plans if they were already in the country. He also transformed FEMA into an effective organization following Hurricane Katrina. His greatest successes have earned few headlines – because the important news is what didn't happen.

At The Chertoff Group, Mr. Chertoff provided high-level strategic counsel to corporate and government leaders on a broad range of security issues, from risk identification and prevention to preparedness, response and recovery. "Risk management has become the CEO's concern," he says. "We help our clients develop comprehensive strategies to manage risk without building barriers that get in the way of carrying on their business."

Before heading up the Department of Homeland Security, Mr. Chertoff served as a federal judge on the U.S. Court of Appeals for the Third Circuit. Earlier, during more than a decade as a federal prosecutor, he investigated and prosecuted cases of political corruption, organized crime, corporate fraud and terrorism – including the investigation of the 9/11 terrorist attacks.

Mr. Chertoff is a magna cum laude graduate of Harvard College (1975) and Harvard Law School (1978). From 1979-1980 he served as a clerk to Supreme Court Justice William Brennan, Jr.

In addition to his role at The Chertoff Group, Mr. Chertoff is also senior of counsel at Covington & Burling LLP, and a member of the firm's White Collar Defense and Investigations practice group.
