Paul is the retired Chairman of the Board of Capital Research and Management Company. Prior to joining Capital in 1985, he was a partner in the law firm of Dechert Price & Rhoads in Washington, D.C. From 1974 to 1977, he was a Senior Attorney for the U.S. Securities and Exchange Commission.

He recently served as acting President and CEO of National Public Radio from September 2013-July 2014. He also serves as Chairman of the Board of the Los Angeles County Museum of Natural History, and Trustee of the Huntington Library, Museum and Gardens in San Marino.

Paul earned a bachelor's degree in economics from Princeton University, an M.B.A. from the Wharton School and a J.D. from the University of Pennsylvania Law School.

Heather Haaga is a practicing artist with a focus on plein air painting—primarily landscapes and still lifes, and has had successful shows in Los Angeles and on the East Coast. She is a trustee of Princeton Theological Seminary, a member of the Advisory Council for Princeton University Art Museum as well as a Trustee for her alma mater, Vassar College. As Chair of the Salzburg Global Seminar, she has helped to envision a new strategic direction for the next decade. Finally, she is a member of the Board of Directors for African Wildlife Foundation.

Part of Penn Law's distinguished lecture series, the Haaga Lecture focuses on leadership and its impact and importance in government. Haaga lecturers provide insight and experience for Penn Law students, in an effort to prepare them for leadership roles in their post-scholastic careers.

2018 Distinguished Haaga Lecture Speaker

Lieutenant General H. R. McMaster

*United States Army, Ret.; former National Security Advisor;
and Perry World House Distinguished Visiting Fellow*



H.R. McMaster served as the country's national security advisor from 2017 to 2018. He served as a commissioned officer in the United States Army for 34 years before retiring as a lieutenant general in June 2018. McMaster is currently the Fouad and Michelle Ajami Senior Fellow at the Hoover Institution and the Bernard and Susan Liautaud Visiting Fellow at the Freeman Spogli Institute, both at Stanford University. He is also a Perry World House Distinguished Visiting Fellow.

From 2014 to 2017, McMaster served as director of the Army Capabilities Integration Center and the deputy commanding general of the U.S. Army Training and Doctrine Command (TRADOC). Before that, he was commanding general of the Maneuver Center of Excellence from June 2012 to July 2014. His wartime experience includes holding commander positions in Afghanistan from 2010 to 2012, in Iraq from 2005 to 2006, and during Operation Desert Storm from 1990 to 1991. He also led or co-led assessments of Iraq strategy and post-war efforts in Iraq.

McMaster was an assistant professor of history at the United States Military Academy from 1994 to 1996 and is the author of the award-winning book, *Dereliction of Duty: Lyndon Johnson, Robert McNamara, the Joint Chiefs of Staff and the Lies that Led to Vietnam*. Born in Philadelphia, he graduated from the United States Military Academy in 1984 and holds a Ph.D. in military history from the University of North Carolina at Chapel Hill.
